This past year can be classified as one of great change and sustained excellence. In November of 2024, I assumed the helm of The Community Fund of Darien upon the retirement of the ever-capable Janet King. The staff and donors trusted the transition as we moved steadily forward in fundraising and grantmaking. With \$790,000 from your generous gifts complemented by a withdrawal from our Endowment, we granted financial support to over three dozen special initiatives in Stamford, Darien, and Norwalk. Thank you!

In my first-time immersion in the intensive, volunteer-guided grant vetting process, I observed scores of neighbors who, as teams, carefully reviewed applications, conducted site visits, analyzed financial statements, and deliberated for hours determining the most efficient and effective allocations of funds to target the community's greatest human service needs.

Thirty-six local agencies and programs received funding to improve the health and well-being of our neighbors in Darien, Norwalk, and Stamford. Additionally, The Community Fund of Darien hosted valuable programs to help our youth thrive by engaging in community service and philanthropy, we convened local professionals and agencies to address social service priorities, and we mobilized volunteers to act.

Your One Donation to The Community Fund of Darien has broad-reaching effectiveness and targeted efficiency that strengthens the fabric of our community and, truly, changes lives.

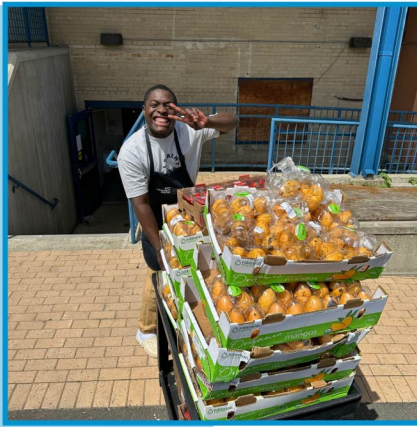

What We Do

Life-changing Grants

The Community Fund of Darien assists our neighbors in Darien, Norwalk, and Stamford by awarding grants to carefully vetted local nonprofits that provide food, shelter, access to physical and mental healthcare, job and skills training, and youth success programs.

Darien Initiatives

The Touch-A-Life Fund provides urgent financial assistance to Darien residents in need. In partnership with the Department of Human Services, the fund helps prevent evictions, keep the lights on by covering utility bills, and ease immediate financial burdens.

In addition, over the past two years we have supported the TeenTalk Counselor at Middlesex Middle School in collaboration with the Darien Public Schools.

Youth Programs

We provide middle and high school students with opportunities to engage in local community service & learn about philanthropy.

Human Services Planning Council

We bring together an expert forum of government, educational and nonprofit leaders, and other local professionals to address social service priorities in Darien.

Thriving Youth Darien

We convene a volunteer coalition of community organizations to promote and empower positive youth development and mental health with the goal of reducing teen substance use thanks to a federal Drug Free Communities Grant administered by Centers for Disease Control and Prevention.

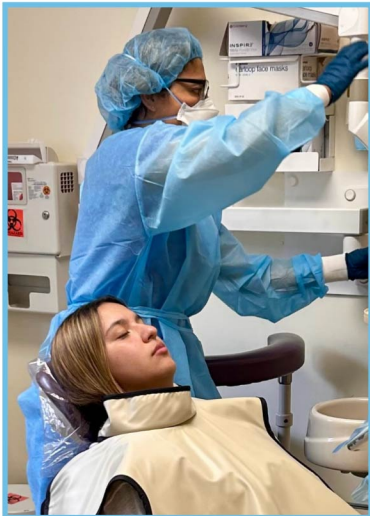

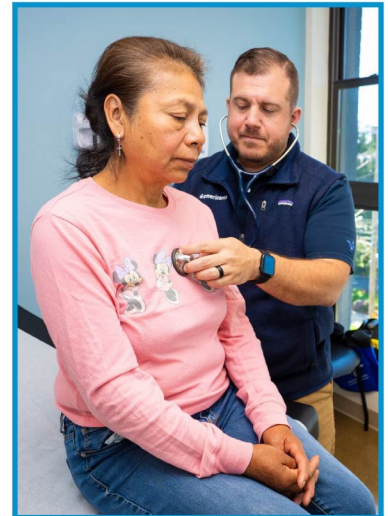

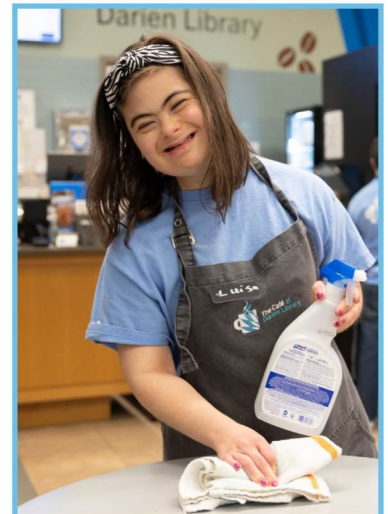

Community Grant Review

Our annual process to evaluate nonprofit applicants to ensure that we are providing grants to the most effective local nonprofit organizations.

This year, 78 community grant review volunteers spent more than 1,400 hours evaluating 65 applications, reviewing financials, and conducting site visits to help determine how funds would be distributed.

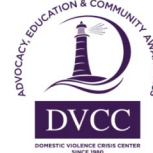

Four Programs to Engage Darien Youth

01 >>> Youth Give Back (YGB)

From fall through spring, 38 Darien 7th and 8th grade students participated in (YGB), contributing over 300 hours of volunteer service. Through meaningful experiences volunteering at local nonprofits, students gained insight into the needs of our surrounding community and the importance of giving back! Students volunteered at Fairgate Farm, Open Doors, Waveny LifeCare Network, At Home In Darien, Person to Person, and Darien Nature Center.



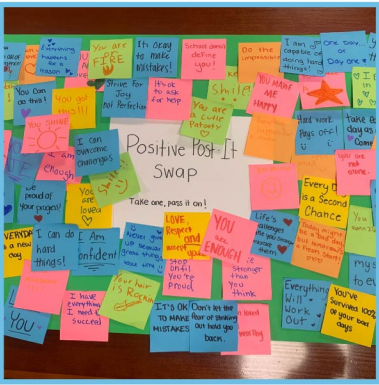
02 >>> Freshman Community Group (FCG)

From fall through spring, 30 Darien 9th graders participated in FCG. Through meetings and volunteer opportunities, the students engaged in discussions about the transition to high school, including stress management, friendship, and substance use. Students also got to learn about local human service needs and gave back to the community through volunteer work!



03 >>> Youth Asset Team (YAT)

This year, 24 Darien 10th - 12th graders participated in the Youth Asset Team (YAT). The students met regularly to engage in meaningful conversations and hands-on activities that support their wellbeing and that of their peers. YAT participated in a variety of impactful experiences, including completing QPR (Question Persuade Refer) suicide prevention training, attending a fentanyl awareness presentation from Song for Charlie, and hearing from a Darien Police Lieutenant about the dangers of driving under the influence.



04 >>> Youth Community Fund (YCF)

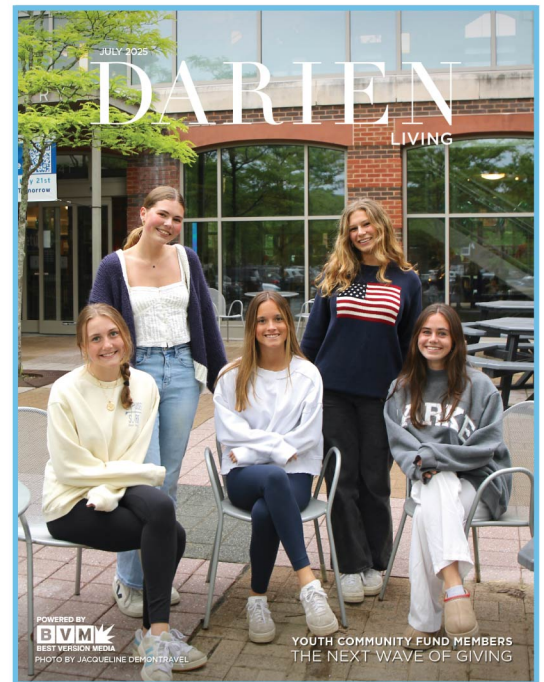
Students learn about philanthropy and the role of nonprofits in our community. Participants engage in a variety of volunteer projects at different local nonprofit organizations. Towards the end of the school year, our Youth Community Fund (YCF) students identify a group of local nonprofit organizations to consider for funding. The YCF students review grant applications and conduct site visits at the nonprofits and collectively agree on how best to allocate the funds. This year, the students awarded a total of \$15,500 to 15 local nonprofits.
